Daycare prices: Multiple Days Per Week **\$15/day** Trial & Single day per week **\$20/day**

Daycare w/ Training **\$250 per week** Dog must come to daycare 5 days a week for a minimum of 3 weeks. Price includes two ½ hour private lessons--one on first day and one on the last day.

Daycare/Sleepover Training Fees: **Daycare w/ Training \$250 per week** Dog must come to daycare 5 days a week for a minimum of 3 weeks.

Sleepover w/ Training \$60 per day--3 weeks, preferred but exceptions can be made by instructor plus one-hour private lesson on pickup day (\$1,345)

One hour private is required before starting either training programs

**\$20 additional fee for pick-up or drop off during non-regular day hour and/or Saturday/Sunday (when offered). * Prices per dog

An application fee of \$20 is required at time of registration per household. All dogs are required to attend a trial day, before being accepted for regular daycare or sleepover. The trial day is so the KETCH staff can get to know them and your dog can be tested for placement in the proper playgroup. For sleepovers: KETCH wants dogs to be happy and relaxed while you are away, some dogs may need more daycare before approval for sleepover. Reservations are required in advance. If someone other than the owner(s) listed on this agreement will be picking up your dog from daycare, please provide KETCH with a written release.

Dog should arrive at KETCH with a leather or cloth leash no longer than 6 feet (no Flexi leashes, please), and a quick release buckle collar with their tag. All training aids, food, medication and bedding for crate, etc...should be provided when dropping off your dog for daycare or sleepover, dog's name must be permanently marked on all supplies. **Daycare dog's supplies will be returned daily including beds.** Dog's nails must be kept at a reasonable length, so others don't get scratched.

****KETCH reserves the right to not accept a dog into daycare for any reason. All rates and hours subject to change.***

While your dog is at K-9 Educational Training Center of Hillsborough they will be given potty breaks, food (supplied by owner), water, and medications (if needed & supplied). In addition he will be exercised, handled, and socialized with people and other animals, in a safe, supervised manner. While he is waiting in between play sessions, they will spend their time in a crate (appropriate for his size), exercise pen or kennel, for their own safety.

Veterinary Treatment Authorization

In the event that your dog becomes ill or hurt while he is in the care of K-9 Educational Training Center of Hillsborough Inc., we will attempt to contact you. If you are not available we will attempt to contact your veterinarian. Should your dog require veterinary attention, and we determine in our sole discretion, that the time exists to safely transport your dog to your veterinarian; we will do so. But, at the discretion of the management of KETCH, your dog may be taken to an Emergency Veterinary Clinic, or the veterinarian of KETCH's choice. It is understood that all expenses incurred due to your dog's illness or accident must be paid in full at the time that you pick up your dog from KETCH. We will not bill you or accept partial payment. There will be a \$20 trip charge per visit to veterinarian.

A ONE HOUR PRIVATE LESSON (\$85) IS REQUIRED before starting either training program

Payment is required in advance upon scheduling for all services. Credit, check or cash.

**\$20 additional fee for pick-up or drop off during non-regular day hour and/or Saturday/Sunday (when offered). * Prices per dog

Vaccinations: For your dog's safety, and the safety of others, KETCH requires your dog to be current on the following vaccinations: ****Rabies, Distemper, Parvo, and Bordetella, -- Provide KETCH with copy of your dog's vaccination history including negative fecal and heartworm test verification with in one year. Keep us updated with future vaccinations. ** Titers accepted.**

****If using frontline or another topical repellent, please apply at least 48 hours prior to dog's arrival.**

What to Bring for daycare/sleepover: Dog should arrive wearing a leather or cloth leash no longer than 6 ft (no Flexi leashes, please), and a quick release buckle collar with their tag. Gentle leaders ok. Dog meals should be individually bagged per day w/name. For your dog's safety, please notify KETCH in writing if someone other than the owners listed on this agreement will be picking up your dog from daycare. **Sleepover checklist is available at front desk.**

Optional items: Dog's name permanently marked on all supplies.

Medicine- Place each bottled medicine in a zip lock baggie. Label what the medicine is for, dosage and when to administer.

Vitamins: Add to bagged food or separate baggie in food baggie.

Treats: Biscuit type only. No rawhides, greenies, edible nylabone etc.

Chew toys: that can be chewed on not up, appropriate for the dog's size. Ex: Kong, marrowbone, etc.

Crate bedding: Dog's name must be on bedding! Types accepted: towel, blanket, sheepskin, bathroom floor mat or area rug (mats have rubber on bottom to prevent dog slipping getting into crate).

Unaccepted bedding: *frayed towels, blankets w/holes, beds with fillers such as beads or foam.*

******* Daycare dog supplies will be returned daily including beds**
